4. FME '93 Conference Update

The programme committee have selected the papers to be presented. The programme and registration forms are now available. The budget was presented to the meeting. Peter Larsen was confident that the conference will be financially viable. A lot of interest has been expressed.

The question of reduced prices for hard cases was discussed. It was agreed that Peter Larsen should be able to offer fixed bursaries. The number available will depend on the financial position of the conference. The committee agreed that particular consideration should be given to enabling delegates from Eastern European countries by offering them bursaries. Alejandro Moya offered to find out if the CEC can offer bursaries.
